**Myofascial Release/Trigger Point Therapy;** sponsored by Texas Chiropractic College Post Graduate Department. 16 hours of instruction and hands-on training to detect and treat myofascial entrapments and related syndromes.

**Degenerative Joint Disease;** sponsored by Texas Chiropractic College Post Graduate Department. 4 hours of instruction describing the etiology and treatment options currently used and new research based options that included joint mobilization.

**Orthopedic Module – Hip and Knee;** sponsored by Logan Chiropractic Post Graduate Department. Clinical evaluation through orthopedic manual testing and radiographical interpretation. 16 hours of classroom instruction and manual testing. Therapy and referral protocols were discussed in detail.

**Clinical Nutrition for the Chiropractic Practice;** sponsored by Parker Chiropractic College Post Graduate Department. 8 hours of classroom instruction. Clinical applications for nutritional considerations were taught as well as recognized protocols for implementation of supplementation and proper eating habits.

**Module I: Introduction to Forensic Chiropractic;** sponsored by Texas Chiropractic College Post Graduate Department. Initial conference to evaluate the practitioner to determine appropriateness of a case as an independent medical examiner. Topics such as: Causation, Medical Appropriateness, Ethics and Understanding the Guides as they apply to local, state and federal applications. 12 hours of instruction with an 8 hour extension assignment to further clarify information received in class. Grant vs. Farnsworth, civil procedure, accepted peer reviewed and referred law and medical publications.

**Module II: Federal Guidelines for Forensic Examinations.** Didactic instruction to state the skill sets needed to perform federal examinations. 12 hours of instruction and 8 hours of extension assignment to demonstrate knowledge of information.

**Hidden Dangers Within Chiropractic Practice;** sponsored by Texas Chiropractic College. Demonstrated the importance of correct documentation of patient history and office notes as it pertains to legal support of office procedures. 4 hours of instruction.

**Protect Your Back – Instructor Seminar;** sponsored by Texas Chiropractic College and the American Red Cross. Instructor training to teach industrial and public health classes to improve the quality of life for employers. 18 hours of instruction.

**CPT Coding 2001** - Didactic and demonstration of proper procedure codes used for billing of medical office procedures. 4 hours of instruction.

**Clinical Aspects of EMG**; sponsored by National University of Health Science. An introductory seminar to teach the clinical application and proper evaluation to determine need for an EMG. 12 hours of instruction.
